2. Interested tenderers may view and inspect vehicle to be sold during office hours, Monday to Friday between 9.00am and 4.00pm at the specified location below.
3. Duly completed bid documents, marked with the tender number and name should be sent to the provided email address or dropped at our offices.

4. The tenderer shall bear all costs associated with the preparation and submission of its tender, and the Procuring Entity, will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the tendering process.
5. The Procuring Entity shall allow the tenderer to review the tender document and the vehicle to be sold free of charge before tendering.
6. A prospective tenderer requiring any clarification of the tender document may notify the Procuring Entity in writing or by post at the entity's address indicated.
7. The procuring entity will announce the tender opening date upon satisfaction of having received adequate bids.
8. The highest bid will be recommended for award. The reserve price of the motor vehicle is KES 1,500,000.

Award Criteria

The Procuring Entity will award the contract to the successful tenderer(s) whose tender has been determined to be substantially responsive and has been determined to be the highest tendered price, subject to the reserve price.

Notification of Intention to enter into a Contract/Notification of Award

Prior to the expiration of the period of tender validity, the Procuring Entity will notify the successful tenderer in writing that its tender has been accepted. Simultaneously the other tenderers shall be notified that their tenders have been unsuccessful.
